Lanna Resources Public Company Limited (the "**Company**") would like to inform that as a result of Siam City Cement Public Company Limited ("**SCCC**") being the joint offeror with Sunrise Equity Company Limited (the "**Tender Offerors**"), in the tender offer for 288,825,699 shares in the Company during the period of August 29, 2024 to October 2, 2024 (the "**Transaction**"), it was determined at the end of the offer period that shareholders accepted the tender offer, accounting for 16.46 percent of the total voting shares of the Company. Consequently, the shareholding structure of the Company has changed, with SCCC holding shares in the Company increasing from 44.99 percent to 61.44 percent of the total voting rights of the Company, based on the information in the Report on the Result of the Tender Offer of Lanna Resources Public Company Limited (Form 256-2) received from the Tender Offerors. This results in the Company becoming a subsidiary of SCCC under the securities law. The details of the change of major shareholders shareholding structure are as shown in the below table.
